



# MANITOBA ORDER IN COUNCIL

## ORDER

1. The designation of Jim Derksen as Vice-chair of the Accessibility Advisory Council (the Council) is revoked.
2. Jim Derksen is designated as Chair of the Council.
3. Yvonne Peters is designated as Vice-chair of the Council.
4. Eileen Clarke is appointed as a member of the Council.
5. The terms of office of the Chair and Vice-chair expire on September 1, 2014, and each continues to hold office as Chair or Vice-chair until he or she is re-appointed, the appointment is revoked or a successor is appointed.
6. The term of office of Eileen Clarke expires on September 1, 2014, and continues until she is re-appointed, the appointment is revoked or a successor is appointed.
7. This Order comes into effect on September 1, 2011.

## AUTHORITY

*The Accessibility Advisory Council Act, C.C.S.M. c. A1.7, provides in part as follows:*

### **Accessibility Advisory Council**

4(1) The Accessibility Advisory Council is hereby established.

### **Appointment of members**

4(2) The council is to consist of at least 6 and not more than 12 members appointed by the Lieutenant Governor in Council.

### **Term of office**

4(5) A member of the council is to be appointed for a term not exceeding three years.

### **Appointment continues**

4(6) A member whose term expires continues to hold office until he or she is re-appointed, the appointment is revoked or a successor is appointed.

### **Chair and vice-chair**

4(7) The Lieutenant Governor in Council must designate one member of the council as chair and another member as vice-chair to act if the chair is absent or unable to act.

## BACKGROUND

1. Jim Derksen was appointed as member and designated as Vice-chair of the Council by Order in Council 329/2011. Yvonne Peters was appointed as member of the Council by Order in Council 329/2011.
2. It is intended that Jim Derksen be designated as Chair, and Yvonne Peters be designated as Vice-chair of the Council.
3. When this Order is in effect, the Council will consist of the following members:
